**3. Minimum Charge Applicable to Large Dual Fuel Customers (per month)-** The monthly minimum charge shall be determined by applying the base rates, set forth in A or B above, to two-thirds of 100,000 therms divided by 365 days multiplied by the number of days therms divided by 365 days multiplied by the number of days (approximately 30) in the billing period.

Gas Importer Tax (per month):** In addition to the rates set forth in (a) to (l) above, a Customer shall pay a tax on natural gas purchased outside New York State from a supplier other than Con Edison and delivered by Con Edison to the Customer. Current and historical tax rates can be found in the "Gas Importers Tax" table (See pg. 31).

**6. Increase in Rates and Charges:** The rates and charges in A to E above are increased by the applicable percentage found in the "Gross Receipts Tax" table to recover local and state gross receipts taxes (See pages 10 and 11).

**7. Billing Payment and Processing (BPP) Charge:** The Billing and Payment Processing charge will be either \$0.94 per bill or no charge for a single service gas Customer or \$0.47 per bill or no charge for a dual service gas Customer. Customers taking service under SC 9, and receiving either a utility consolidated bill or a marketer consolidated bill, are not subject to the BPP.

**8. Revenue Decoupling Mechanism Adjustment:** All customers excluding SC9 (b), (d), (f), (h), and (j) are subject to a Revenue Decoupling Mechanism Adjustment as explained in General Information Section IX.

**9. System Benefits Charge:** For all Customers, the rates set forth in (a) to (j) above are subject to a System Benefits Charge as explained in General Information Section IX

**10. Temporary State Assessment Surcharge:** For all Customers, the rates set forth in (a) to (j) above are subject to a Temporary State Assessment Surcharge as explained in General Information Section IX
