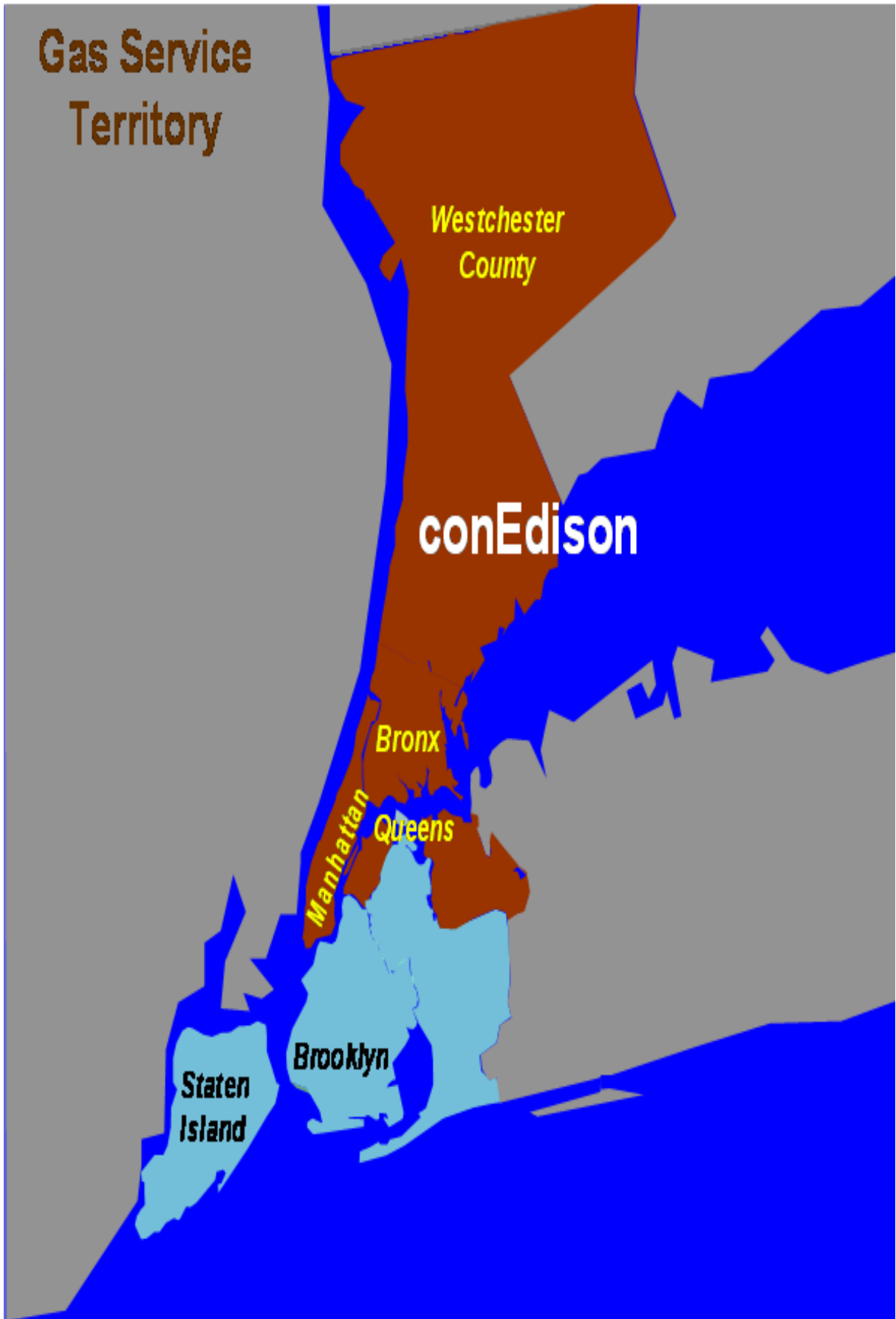

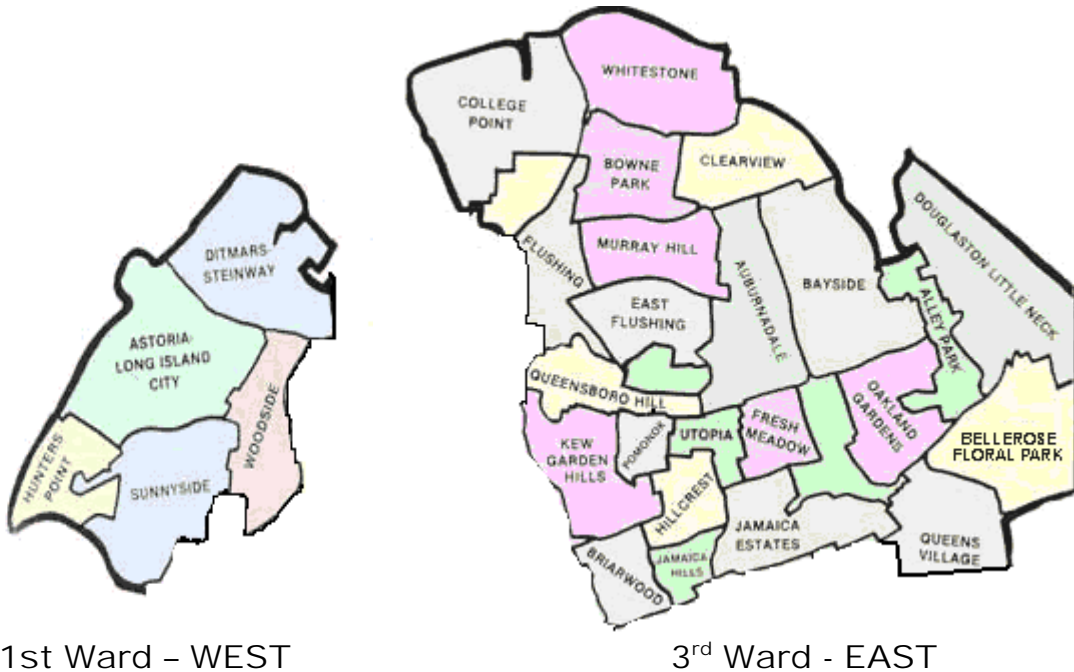

The 1st and 3rd Queens Wards are Con Edison Gas Service Territory

Gas service is available in small sections of Briarwood, Jamaica Estates and Queens Village.

Western border is the Van Wyck Expressway. Con Edison has the east side of it only, Park Drive East.

South border, small section s/o the Grand Central Parkway from 138 Street to 164 Place (not to include whole blocks) from 164 Place to 168 Street, n/s of Grand Central Parkway is the borderline. Grand Central Parkway south service road is the border line from 168 Street to 173 Street. East of this, North Side of Grand Central Parkway is border line to the Clearview Expressway.

North of Grand Central Parkway up to 82 Avenue, then n/s of Grand Central Parkway is border line east to Springfield Boulevard.

East of Springfield Boulevard, n/s of Braddock Avenue is the border line from Springfield Boulevard to Gettysburg Street in Queens Village.

The North side of Jamaica Avenue is the border e/o Gettysburg Street to 257 Street in Bellerose to the Nassau County line.

National Grid is responsible for the remaining sections of Queens' gas service installations.
