The Company may require a Customer to provide adequate security for the payment of the balance of the interconnection costs due the Company under the payment agreement.
- (2) An annual charge of 10 percent of the capital costs of interconnection, including the costs to cover property taxes and operation and maintenance expenses. The annual charge shall be determined by multiplying the rate of 10 percent by the total capital costs of interconnection. The annual charge is payable by the Customer in monthly installments equal to one-twelfth of the annual charge.

Failure of the Customer to pay any of the interconnection charges or annual charges, when due, shall be cause for termination of service in accordance with the procedures specified in this Rate Schedule.

Fuel Adjustment

The charges to the Customer set forth herein shall be subject to a fuel adjustment per Mlb of steam supplied hereunder (as explained in General Information Section 8).

The estimate is subject to the Company's approval.

The Company will set the contract demand if the Customer does not specify a contract demand in its request for service or within 30 days of submitting such request, or within 30 days of the Company becoming aware that the Customer should be billed under this Service Classification. The Company will set the contract demand at the maximum potential demand during the months of December through March. The contract demand will be reasonably determined using information available to the Company, such as an engineering analysis performed by the Company of the Customer's steam-consuming equipment and diversity of load, premises to be served, information supplied by the Customer at the Company's request, and the Customer's historical usage over the past 36 months, if available.

2. The contract demand that is set by the Customer or the Company under this Service Classification shall remain in effect unless and until the Customer or the Company revises the contract demand, as described hereunder, or the maximum demand exceeds the contract demand by more than two percent within the months of December through March, inclusive. If the maximum demand exceeds the contract demand by more than two percent for any month within the months of December through March, such higher maximum demand (a) shall be considered to be a Customer-set contract demand; and (b) will become the Customer-set contract demand for that month and thereafter unless and until exceeded by a still higher maximum demand, which in turn shall likewise be subject to the foregoing conditions.

No surcharge will be assessed the first time that the monthly maximum demand on an account exceeds the initially-set contract demand (that is, the contract demand established at the Customer's initiation of service) by more than two percent.

3. If the monthly maximum demand within the months of December through March, inclusive, exceeds the currently effective contract demand by more than two percent, a surcharge equal to the demand registered in excess of the current contract demand multiplied by the contract demand rate multiplied by the Multiplier will apply to the monthly bill. The Multiplier will be equal to the number of months since the Customer commenced service under this Service Classification; provided, however, that the number shall not be more than 12.

The surcharges shall not be applicable to any portion of the increased contract demand attributable to a colder-than-design weather variable. The "weather variable" consists of the weighted average of the temperature at the peak hour (80% weighting) and the average temperature over the preceding 24 hours (20% weighting). "Design weather" is defined as a weather variable of 5 degrees F. If a Customer's peak demand for a month exceeds the contract demand and the weather variable for the customer's peak hour is colder than the design weather, the Company will apply a factor based on the slope of the Company's steam system's design demand curve for that winter period to determine what the customer's peak demand would have been for the design weather. The surcharge shall apply only for that amount, if any, by which the design weather-adjusted Customer peak demand exceeds the contract demand.

Such documentation must clearly demonstrate that the price of steam is a major factor in the Customer's decision to pursue competitive alternatives. The Customer must also provide any additional information requested by the Company that it reasonably requires to analyze the application.
- (2) The Customer must agree to use exclusively the Company's steam service for the purposes of heating and/or cooling for a period of time to be stipulated in the Service Agreement.
- (3) The Customer must maintain a minimum level of steam usage during any 12-month period as stipulated in the Service Agreement.

The Company will review the Customer's application and determine eligibility for service under this Service Classification on a case-by-case basis. In making such a determination, the Company will consider the viability of the Customer's competitive alternatives to the Company's steam service, as well as the practical aspects of securing the alternatives (e.g., ability to secure environmental permits, building permits, or required capital).

The Company will respond to applications for service under this Service Classification within 30 calendar days. When requested by a Customer, the Company will provide the basis for its decision not to offer a negotiated rate within 15 business days of the later of the date of the decision or the date of the request. A Customer who either fails to receive a negotiated rate or objects to the offered rate may appeal the Company's decision to the Department of Public Service's Director of Economic Development and Policy Coordination.

Service Agreement

The Company and a Customer determined by the Company to be eligible for service under this Service Classification shall negotiate and execute a Service Agreement prior to the commencement of service hereunder. The Service Agreement shall contain all information necessary for the Company to supply steam service to the Customer including, but not limited to:

- (1) the term of service, including the period of time during which the Customer agrees to use exclusively the Company's steam service for the purposes of heating and/or cooling, options for continuing service and options for canceling service;
- (2) the exact character of service and steam requirements, including the required minimum level of steam usage during any 12-month period, and Customer's equipment to be served;
- (3) additional facilities to be constructed or installed; and
- (4) a listing of all charges to be billed by the Company and paid by the Customer for services rendered and for facilities constructed or installed.

Service under this Service Classification may be terminated at the Company's option for breach of the Service Agreement by the Customer. In the event of such termination of service, the Customer shall be eligible for steam service under its otherwise applicable Service Classification after making any prepayment required under General Information Sections 3 and 4.

Rate

The specific charges under this Service Classification will be stated in the negotiated Service Agreement executed by the Company and each Customer. The rate per Mlb included in any Service Agreement with any Customer shall be no lower than the Company's marginal cost of steam service to the Customer per Mlb of steam supplied plus a contribution to fixed costs. Unless otherwise agreed to by the Customer and upon full disclosure, the negotiated rate shall not exceed the tariff rate in effect for or applicable to the Customer at the time the Service Agreement is executed. The Company may, at its discretion, provide monthly bill reductions from otherwise applicable rates or make a one-time payment of the net present value of a bill reduction, provided that the Customer commits to a contract term that is equivalent to the term value of the bill reduction.

The Company will provide marginal cost calculations to Staff and may request trade secret protection for such calculations. The Company shall use marginal costs appropriate to the length of the Service Agreement. Capital costs will not be included if short run marginal costs are used.

The Company may require a Customer to provide adequate security for the payment of the balance of the interconnection costs due the Company under the payment agreement.
- (2) An annual charge of 10 percent of the capital costs of interconnection, including the costs to cover property taxes and operation and maintenance expenses. The annual charge shall be determined by multiplying the rate of 10 percent by the total capital costs of interconnection. The annual charge is payable by the Customer in monthly installments equal to one-twelfth of the annual charge.

Failure of the Customer to pay any of the interconnection charges or annual charges, when due, shall be cause for termination of service in accordance with the procedures specified in this Rate Schedule.

The Usage Charge set forth herein shall be subject to a fuel adjustment per Mlb of steam supplied hereunder (as explained in General Information Section 8).

Increase in Rates and Charges

The rates and charges under this Service Classification including fuel adjustment and customer charge are increased by the applicable percentage as explained in General Information Section 9 and shown on the related Statement.

Determination of Demand

The contract demand under this Service Classification shall be the contract demand as specified in the Customer's request for service hereunder (expressed in 1000 pounds of steam per hour), unless and until a higher maximum demand is created by the Customer within the months of November through April, inclusive, in which case such higher maximum demand shall become the contract demand for that month and thereafter unless and until exceeded by a still higher maximum demand, which in turn shall likewise be subject to the foregoing conditions.

If the monthly maximum demand within the months of November through April, inclusive, exceeds the contract demand by ten percent or less, a surcharge equal to twelve times the monthly contract demand rate for the excess in demand will apply to the monthly bill. If the monthly maximum demand within the months of November through April, inclusive, exceeds the contract demand by more than ten percent, a surcharge equal to twenty-four times the monthly contract demand rate for the excess in demand will apply to the monthly bill. For peak load forecasting purposes, weather is measured by a "weather variable" which consists of the weighted average of the temperature at the peak hour (80% weighting) and the average temperature over the preceding 24 hours (20% weighting). "Design weather" is defined as a weather variable of 5 degrees F. The surcharges shall not be applicable to any portion of the increased contract demand attributable to a colder-than-design weather variable.

If a Customer's peak demand for a month exceeds the contract demand and the weather variable for the customer's peak hour is colder than the design weather, the Company will apply a factor based on the slope of the Company's steam system's design demand curve for that winter period to determine what the customer's peak demand would have been for the design weather. The surcharge shall apply only for that amount, if any, by which the design weather-adjusted Customer peak demand exceeds the contract demand.

Determination of Demand - Continued

A Customer applying for service under this Service Classification for the first time is required to establish an initial contract demand on the basis of a reasonable estimate provided by a professional engineer retained by the Customer. The estimate is subject to the Company's approval. In the event that such initially-established contract demand is exceeded, or a higher demand is later specified by the Customer, for any month within the months of November through April, no retroactive surcharge will be imposed, but such higher maximum demand shall become the contract demand for that month and thereafter ("Revised Contract Demand"). In the event that the Revised Contract Demand is exceeded thereafter by a still higher demand, the provisions included in the first two paragraphs under this Determination of Demand provision for this Service Classification will be applicable.

Whenever service is terminated to a Customer's premises and the same Customer applies for, and receives service, at the same location, within what would have been the same billing period, but for the termination of service, the maximum demand for the billing period will be determined as though there had been no termination of service.

The Company will install a demand-measuring device of a type approved by the Public Service Commission for the determination of maximum demand. The maximum demand, when determined by a demand meter, shall be the highest 30-minute integrated demand occurring during the billing period in which such use is made. The integrated demand is the average of the pounds of steam use occurring in a 30-minute period, which average, if used continuously for 30 minutes, would produce the pounds of steam actually consumed during such period.

Term

Subject to the Availability section of this Service Classification, the term of the agreement for service shall be for a period ending no less than one year from the beginning of service under this Service Classification, and shall continue after the end of such period until terminated by the Customer upon thirty days' prior written notice, or by the Company in accordance with law or the provisions of this Rate Schedule.

Temporary Discontinuance of Service

A Customer who requests a temporary discontinuance of service will be required to pay the monthly contract demand charge and the monthly customer charge for each month that service is discontinued. Service will be available under this Service Classification on a pilot program basis, on a first-come first-served basis, until at least September 30, 2002, and will be limited to a total of 100,000 pounds of steam per hour of supply capacity during the months of November through April. Commencement of service under this Service Classification will be limited in each of the 12-month periods commencing October 1, 2000 and October 1, 2001 to no more than three new Customers for their full steam requirements and to no more than two existing Customers under Service Classification Nos. 2 and 3 for increases in their monthly steam requirements. For existing Customers, the increase in steam requirements will be measured on a separate meter, installed by the Company at Customer expense, unless such usage cannot be isolated for separate metering, in which case the increase in the Customer's steam requirements will be established in advance by the Company and the Customer. The Company may seek Commission approval to reduce the hourly volume of steam served under this Service Classification or to otherwise limit this program, at any time, if necessary to maintain system reliability.

Special Provisions

- A. No credit will be given to either a Customer or third-party supplier for net excess deliveries in any month unless the Company agrees in advance to accept such excess deliveries, in which case the Company will pay the Customer for the excess at the Company's average cost of fuel inclusive of fuel costs recovered through the Fuel Adjustment.
- B. Service under this Service Classification will not be provided or will be terminated unless the third-party supplier executes and complies with an interconnection agreement with the Company, requiring, among its terms, that the third-party supplier:
 - (1) pay the cost of connecting its plant to the Company's steam system, including all necessary metering and telecommunications;
 - (2) use best efforts to reasonably match, at all times, its steam supply to the requirements of the Customers that it supplies;
 - (3) use best efforts to limit deliveries of steam, at all times, to the sum of the loads of the Customers that it supplies plus losses, or as otherwise limited by the Company's steam system operator based on steam system operating constraints;
 - (4) meet the Company's steam quality specifications, at all times, for any steam deliveries; and
 - (5) comply, at all times, with the Company's safety and operating procedures.
- C. A Customer may request a temporary discontinuance of service by notifying the Company in writing at least five days in advance of the date on which each temporary discontinuance is to begin specifying the date on which service is to be discontinued and the date on which service is to be resumed. The Company may elect not to physically disconnect service at the service valve. In the event that a Customer takes service during a temporary discontinuance period, the Customer will be billed in accordance with this Service Classification.
- D. For Riders that may be applied to this Service Classification, see General Information Section 7.
- E. Requests for service under this Service Classification shall be made in writing.
