

**OFFICIAL RULES**  
**Utility Thermal Energy Network (UTEN) Mount Vernon Pilot Project**  
**Gift Card Contest**

**SPONSOR:** The UTEN Mount Vernon Pilot Project Gift Card Contest is sponsored by Consolidated Edison Company of New York, Inc. (Con Edison), 4 Irving Place, New York, NY 10003.

**ELIGIBILITY:** The contest is open to existing utility customers of Con Edison (over the age of 18) who receive an invitation to allow building access by Con Edison (and to include Con Edison contractors on behalf of Con Edison in all appropriate instances whether or not specifically mentioned) to certain Mount Vernon buildings that are potential participants in the Con Edison UTEN Mount Vernon Pilot Project. The building access is for the purpose of introducing eligible customers to the pilot project and to work with each eligible customer to perform an energy assessment to determine if the eligible customer is suitable for participation in the project. Only Con Edison electric and gas customers that receive an invitation are eligible for the drawing and only one prize per customer is permitted. No purchase is necessary to enter or win.

**CONTEST PERIOD:** There is a defined period during which eligible Con Edison customers can permit the building access and cooperate with Con Edison in the completion of the energy assessment to receive the prize: July 1, 2024 – January 31, 2025, at 12 AM EST, which was revised and updated from July 1, 2024 – December 31, 2024 at 12 AM EST, and with an increase in contest prize to encourage greater participation, and all winners prior to and after the increase in contest prize to receive the increase in contest prize. The selection of prize winners will occur on a rolling basis consistent with the contest period.

**HOW TO BE ELIGIBLE FOR A PRIZE:** An eligible customer is eligible for a prize by allowing building access and the completion of an energy audit within the contest period. Participation constitutes entrant's full and unconditional agreement to these Official Rules, as well as the decisions of Con Edison, which are final and binding in all matters related to the contest. Winning a gift card prize is contingent upon fulfilling all of the requirements set forth herein and being selected for the prize after completion of the contest requirements.

**REFERRAL PRIZE AWARD:** An eligible customer will also be awarded a referral prize award for each referral of another eligible customer that is not at the time of the referral a contest participant and when such referred eligible customer allows building access and the completion of an energy audit within the contest period. Participation by any referred eligible customer constitutes entrant's full and unconditional agreement to these Official Rules, as well as the decisions of Con Edison, which are final and binding in all matters related to the contest. Winning a gift card prize by a referred eligible customer is contingent upon fulfilling all of the requirements set forth herein and being selected for the prize after completion of the contest requirements. The referral prize award is added to the contest in order to encourage greater participation, and all eligible customers that refer another eligible customer prior to the availability of the referral prize award, if any, contacted to receive a referral prize award.

**GEOGRAPHIC AREA OF THE CONTEST:** The contest, the awarding of the prize for completion of the contest requirements, and the referral prize award will be in Mount Vernon, New York.

**GIFT CARDS:** All eligible customers (including referred eligible customers that are not at the time of the referral a contest participant) that allow building access and the completion of an energy audit during the contest period will receive a \$200 gift card. An additional \$50 gift card as a referral prize award will be awarded to any eligible customer that refers another eligible customer that is not at the time of the referral a contest participant and when such referred eligible customer allows building access and the completion of an energy audit during the contest period. Current or former employees of Con Edison and its contractors will not fall likely into the category of eligible customers, but, in any event, no current or former employees of Con Edison and its contractors and their affiliates are eligible to receive gift cards. All eligible customers that satisfy the contest requirements shall receive a gift card prize, and there are no other estimated or actual odds of winning. All eligible customers that satisfy the referral prize award requirements will

receive a referral prize award, and there are no other estimated or actual odds of winning. Winners will be responsible for any taxes associated with the receipt of a contest prize.

**WINNERS NOTIFICATION:** Winners will be notified of prize awards by correspondence or in person. Notification will be made to an eligible customer following the time that an eligible customer satisfies the contest requirements by allowing building access and the completion of an energy audit.

**USE OF ALL ENERGY ASSESSMENTS:** All energy assessments become the property of Con Edison. Con Edison will not share, reveal or disclose any information about entrants, except as described henceforth: Con Edison may analyze energy assessments and report, summarize, or describe them to any party; however, no information identifying any individual customer will appear in any summary, report, or description of the energy assessment results provided to Con Edison.

**TERMS AND CONDITIONS AND RESTRICTIONS:** Con Edison shall not be liable to any contest winner of a prize or referral prize award for the winner's failure to respond to notification from Con Edison of having been selected to receive a gift card. Con Edison shall not be liable for any failure to supply or delay in providing any gift card or any part thereof, by reason of any acts of God, any action(s) by any governmental or quasi-governmental entity, or any other cause beyond the control of Con Edison unless otherwise required by law. Neither Con Edison nor its contractors are responsible for: (a) late or incomplete performance; or (b) technical failures of any kinds in processing gift cards to winners.

Any entrant who violates these Official Rules may be disqualified. Any person who has entered the contest may be asked to confirm information and eligibility and to help ensure that the use of any information will not bring Con Edison into public disrepute, contempt, scandal or ridicule or reflect unfavorably on the contest or Con Edison. Con Edison has the right to cancel or suspend the contest, in its sole discretion, for any reason or no reason.

**LIMITATIONS OF LIABILITY:** Con Edison and the employees, officers, directors, shareholders, agents and representatives of Con Edison and their respective parent companies, affiliates, subsidiaries, advertising, promotion, and agencies, and legal advisors are not responsible for and shall not be liable for: (i) late, lost, delayed, damaged, misdirected, stolen, incomplete, illegible, unintelligible or postage-due entries, notices, releases, forms, affidavits, or other correspondence; (ii) telephone, electronic, hardware or software program, network, Internet, or computer malfunctions, failures, interruptions or difficulties of any kind; (iii) failed, incomplete, garbled, or delayed computer transmissions; (iv) any condition caused by events beyond the control of Con Edison that may cause information provided or the contest to be disrupted, corrupted or accessed by unauthorized third parties; (v) any injuries, losses, or damages of any kind arising in connection with or as a result of the prize, or acceptance, possession, or use of the prize, or from participation in the contest to the extent permitted by law including without limitation, personal injury, death, and property damage, and claims based on publicity rights, defamation, or invasion of privacy; or (vi) any printing or typographical errors in any materials associated with the contest. By accepting the listed prize, the winner or the winner's designee hereby releases Con Edison from all liability described herein.

**PRIVACY:** Information collected from entrant will be used for analysis purposes to help benefit Con Edison business activity. Con Edison will not sell or trade information received in connection with the contest to outside parties. Participants may provide certain personally identifiable information. Participation is completely voluntary and so eligible customers therefore have a choice whether or not to disclose this information. The requested information may typically include contact information (such as name and email address), and demographic information (such as range of household income). Con Edison will not share or sell the email addresses of entrants to any other entity. Information collected from entrants and shared with Con Edison is subject to Con Edison's privacy policy.
