**SUMMARY ANNUAL REPORT
FOR THE CONSOLIDATED EDISON RETIREMENT PLAN
PLAN NUMBER 001**

The Pension Protection Act of 2006 (PPA) has changed the annual disclosure requirements for participants in a defined benefit pension plan. The Consolidated Edison Retirement Plan (Retirement Plan) Plan Number 001 is subject to the new disclosure rules which became effective with Plan Year 2008.

In the past, federal law required that each year participants receive a Summary Annual Report (SAR) that included certain financial information for the Retirement Plan as of the end of the plan year. Instead of distributing an SAR, the new rules under the PPA require that all participants are notified each year of the funded status of the Plan.

The notice provides the funding status of the Plan; details about how the Plan's assets are invested; and a summary of federal rules governing the termination of pension plans and of benefit payments guaranteed by the Pension Benefit Guaranty Corporation should a company decide to discontinue its pension plan with insufficient assets to pay for benefits earned.

**SUMMARY ANNUAL REPORT
FOR THE UNIFORM GROUP INSURANCE PLAN FOR ALL EMPLOYEES
PLAN NUMBER 502**

This is a summary of the annual report of The Consolidated Edison Group Life Insurance Plan, EIN 13-5009340, Plan No. 502, for period January 01, 2015 through December 31, 2015. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has an insurance contract with Metropolitan Life Insurance Company to pay certain life insurance and Accidental Death & Dismemberment claims incurred under the terms of the plan.

Because it is a so called "experience-rated" contract, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2015, the premiums paid under such "experience-rated" contract were \$15,190,813 and the total of all benefit claims paid under the contract during the plan year was \$14,528,801.

Basic Financial Statement

Voluntary Employees' Beneficiary Association (VEBA) Trusts were established as the funding mediums to provide for the cost of postretirement life insurance under the Plan.

The value of plan assets, after subtracting liabilities of the plan, was \$59,888,493 as of December 31, 2015, compared to \$62,501,498 as of January 01, 2015. During the plan year the plan experienced a decrease in its net assets of \$2,613,005. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$9,008,114, including employer contributions of \$6,083,778, employee contributions of \$2,508,861, and earnings from investments of (\$167,701).

Plan expenses were \$11,621,119. These expenses included \$180,839 in administrative expenses, and \$11,440,280 in benefits paid to participants and beneficiaries.

This is a summary of the annual report of The Consolidated Edison Retiree Health Program for Weekly Employees (EIN 13-5009340) for the plan year January 01, 2015 through December 31, 2015. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has insurance contracts with EmblemHealth, United Healthcare Insurance Company and Aetna Health, Inc. (A New York Corporation) to pay certain health claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2015 were \$1,230,453.

Basic Financial Statement

Benefits under the plan are provided by a Voluntary Employees' Beneficiary Association (VEBA) Trust.

The value of plan assets, after subtracting liabilities of the plan, was \$484,067,374 as of December 31, 2015, compared to \$532,054,560 as of January 01, 2015. During the plan year, the plan experienced a decrease in its net assets of \$47,987,186. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$27,528,204, including employee contributions of \$18,803,018, and earnings from investments of (\$4,353,648).

Plan expenses were \$82,615,390. These expenses included \$3,291,022 in administrative expenses, and \$79,324,368 in benefits paid to participants and beneficiaries.

- Fiduciary information, including transactions between the plan and parties-in-interest (that is, persons who have certain relationships with the plan)
- Loans or other obligations in default
- Leases in default
- Transactions in excess of 5 percent of plan assets
- Actuarial information regarding the funding of the plan
- Insurance information including sales commissions paid by insurance carriers
- Financial information and information on payments to service providers
- Information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates

If you request a copy of the full annual report, these two statements and accompanying notes will be included as part of the report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally-protected right to examine the annual report at the main office of the plan, the Benefits Department, 15th Floor, 4 Irving Place, New York, New York 10003, and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
